



# Call for Candidates for AMA Nomination for the ACGME Review Committee for Internal Medicine

The AMA is soliciting AMA member candidates for nomination by the AMA Board of Trustees for the **Accreditation Council for Graduate Medical Education Review Committee for Internal Medicine** (ACGME RC-IM) for two positions: 1) Hematology Oncology and 2) Rheumatology.

## TERM

The term of the positions is 6 years, from July 1, 2026, through June 30, 2032.

## TIME REQUIREMENT

Nominees must be able to devote sufficient time to prepare for and participate in three RC meetings per year, 2-3 days per meeting, as well as contribute to RC-IM subcommittee work as assigned. The RC-IM offers members the option to attend meetings either in person or virtually. The RC-IM expects members to attend at least two meetings in person per year held at the ACGME headquarters in Chicago, IL.

## CRITERIA FOR AMA NOMINATION TO ACGME RC-IM

### ACGME RC-IM Requirements for this Opportunity

1. **Position 1:** Nominees must be currently certified by the American Board of Internal Medicine or the American Osteopathic Board of Internal Medicine in **hematology and medical oncology**.  
  
**Position 2:** Nominees must be currently certified by the American Board of Internal Medicine or the American Osteopathic Board of Internal Medicine in **rheumatology**.
2. Nominees should be currently (or less than 5 years removed from having been) a program director of a hematology and medical oncology fellowship program (**Position 1**) or a rheumatology fellowship program (**Position 2**) that is accredited by the ACGME and has a current status of "Continued Accreditation".
3. Nominees must have current or past association with graduate medical education.

4. Nominees should participate in major specialty societies.
5. Nominees must be skilled in the use of computers (communication with staff is primarily through email, and members will use electronic systems for receipt of agenda materials, program reviews, reimbursement of expenses, and peer evaluations).
6. Nominees must demonstrate the ability to work collaboratively and express views clearly and concisely.
7. Nominees must be able to devote sufficient time to prepare for and participate in three RC meetings per year, 2-3 days per meeting, as well as contribute to RC-IM subcommittee work as assigned. The RC-IM offers members the option to attend meetings either in person or virtually. The RC-IM expects members to attend at least two meetings in person per year held at the ACGME headquarters in Chicago, IL.
8. Nominees must not be at the same institution as any current member of the RC-IM. Although the RC-IM may have multiple members from the same state, they may not be from the same institution. Accordingly, individuals must not be nominated from the following institutions:

1. Completed electronic **Application for AMA Nomination for External Leadership Position – ACGME RC-IM** (MS Word document preferred). This document is included on the AMA [Medical Education Leadership Opportunities](#) Web page.
2. Current **abbreviated curriculum vitae** [not to exceed three (3) pages].
3. Current **full curriculum vitae**.
4. *Optional*: One letter of recommendation addressed to the AMA. No more than one letter of recommendation will be accepted. Note that, if nominated, the letter of recommendation may be included as part of the nominee materials sent to the requesting organization.
